

Upper Dublin Township Recreation Scholarship Guidelines

Through the Upper Dublin Township Recreation Scholarship, there are financial assistance services available for qualifying Upper Dublin Township families' children, hereafter to be referred to as Participant. Financial assistance is available for programs offered by the following organizations:

- Upper Dublin Parks & Recreation (UDP&R) - summer camp programs
- Upper Dublin Junior Athletic Association (UDJAA) - football, baseball, softball, cheerleading, field hockey, basketball
- Upper Dublin Soccer Club (UDSC) - recreational soccer
- Upper Dublin Aquatic Club (UDAC) - swimming, diving and water polo
- Crooked Crosse Lacrosse Club for Boys (CCLC-B) - boys lacrosse
- Crooked Crosse Lacrosse Club for Girls (CCLC-G) - girls lacrosse

Terms:

- Financial Assistance will only be given to those Participants that reside in Upper Dublin Township.
- Anyone facing a temporary hardship may qualify for funding. Please complete the Scholarship application and contact Tammy Echevarria at 215-643-1600 x3241 or techevarria@upperdublin.net for details.
- Assistance will be directly connected to the Free and Reduced Lunch Program run by the Upper Dublin School District.
- Applications will be available from the Parks & Recreation Department online and at the UDP&R office year-round. Applications will be processed on a first come, first served basis. Applications will be accepted until the Scholarship Funds are exhausted.
- Applicants must provide their letter of approval for the Free and Reduced Lunch Program, which is issued by Upper Dublin School District. The amount of assistance that will be provided to the Participant will be determined by this letter.
- All applications will be processed by the Director of Parks & Recreation and the Recreation Superintendent. After processing, you will receive instructions on how to register for the desired programs.
- For applicants that do not attend an Upper Dublin School District school, but do reside in the township, personal information about household finances and the # of people in the household must be submitted and will be applied to the District's sliding scale to determine what level of support, if any at all, can be provided.
- Each organization manages its own scholarship fund so the maximum amount an individual or household may receive will vary from an organization to organization.

- **For UDP&R programs only:** Completed program registrations must be mailed-in or brought to the UDP&R office and accompanied by a **completed program registration form**. Online registration is not available for this type of registration. Participants qualifying for the **Reduced Lunch Program** are required to **pay 15% of the program's total fee**. Participants qualifying for the **Free Lunch Program** are required to **pay 5% of the program's total fee**. Payment is due at the time of registration. All additional program-related fees are the sole responsibility of the Participant. The maximum amount a Participant can receive is **\$250.00**. The maximum amount a Household can receive is **\$600.00**. Additional funds may be available based on the number of requests we receive
